The main focal points of this agenda will be discussed more in depth in five working groups focusing on the conditions and challenges of implementing participation, good governance and sustainable development in research, social innovation, cohesion policy and inclusion in the EUSDR and other EU macro-regional strategies.

The program offers a unique opportunity to get into contact and exchange with non-state stakeholders, academics, experts, local actors and organised civil society from the entire Danube Region.
